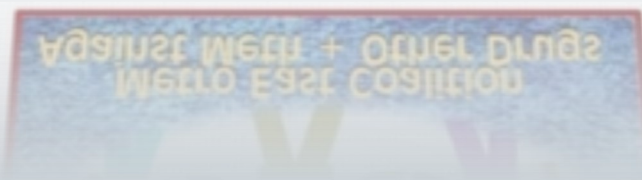

ONLINE REGISTRATION

Everyone must register online. If you register more than 1 person, you must complete registration information for EACH person attending. On-site registration will not be available. **Registration ends on April 8, 2020 or when capacity is reached.** Early registration is recommended. This conference will fill to capacity quickly and there will be a waiting list.

REGISTRATION FEE

The registration fee is **\$50 per person** for the 2-day conference. The registration fee applies regardless if you attend the conference 1 or 2 days. Each person attending must register online. Registration fee includes morning refreshments, lunch, and training sessions for both days. Online registration will allow you to pay either online with a credit card or by mailing in a check. You will need to choose your method of payment when you go through the online registration process.
